Earlier this month, a \$400 million increase in Alzheimer's research funding was signed into law, increasing federal funding at the National Institutes of Health (NIH) to nearly \$1.4 billion. After years of stagnant funding, this is the second year in a row the Alzheimer's Association request for historic funding increases has been acted on by our federal leaders.
